RE: FALSIFIED CHLOROQUINE PRODUCTS CIRCULATING IN AFRICA

National Drug Authority received an alert from WHO that 9 different falsified Chloroquine products have been reported in 3 countries of Africa- Cameroon, Democratic Republic of Congo and Niger as shown below:-
